# **Graduate Student Responsible Conduct of Research**

University SAP 15.99.99.M0.04 went into effect August 6, 2020. The requirements outlined in this procedure apply to all postdoctoral researchers and any undergraduate or graduate student participating in research funded internally or externally (e.g., sponsored research or research gift). Please see the FAQs for specifics regarding what training you may be required to complete. The requirements will depend on whether you are an undergraduate student, graduate student, or postdoctoral research and the type of funding supporting the research in which you are involved.
